Position: Junior Legal Associate or Paralegal

Location: This position is located on island in Barbuda or Antigua. If in Antigua, the role will involve frequent travel between Antigua and Barbuda, with occasional stays in Barbuda required.

Job Description

It is essential that applicants have practical legal experience ideally in Antigua and Barbuda or other jurisdictions in the Eastern Caribbean or in the wider Caribbean region. It is desirable if applicants also have expertise and experience in civil litigation, including judicial review and environmental and planning law.

Key Responsibilities:

- 1. Conduct comprehensive legal research and analysis.
- 2. Draft and prepare legal documents, including witness statements.
- 3. Take proofs of evidence and compile comprehensive client files.
- 4. Liaise with clients and other legal professionals as required.
